

“Lexus Ultimate Date Night at Hershey Theatre” Sweepstakes

**OFFICIAL RULES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF PENNSYLVANIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR ENTRY IN THE STATE OF PENNSYLVANIA ONLY AND WILL BE GOVERNED BY U.S. LAW. **DATES OF SWEEPSTAKES:** The “Lexus Ultimate Date Night at the Hershey Theatre” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Time (“ET”) on April 26, 2026 and ends at 11:59 p.m. ET on June 14, 2026 (the “Sweepstakes Period”).

**ELIGIBILITY:** The Sweepstakes is open only to legal permanent residents of Pennsylvania who live within a 75-mile radius of the Hershey Theatre located at (15 E Caracas Ave, Hershey, PA 17033 ) are eighteen (18) years of age at time of entry (each, an “Entrant”). (the “Website”) during the Sweepstakes Period and complete the official entry form (the “Entry Form”) in its entirety, including your first name, last name, address, city, state, zip code, email address, telephone number where you can be reached for potential prize winning notifications (including area code), if selected, and date of birth. Then, click the “Submit” button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.**

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, garbled, stolen, delayed, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

**WINNER SELECTION/NOTIFICATION:** On or about June 15, 2026, one (1) potential prize winner (the "Prize Winner") will be selected at random from among all eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the Sweepstakes Administrator whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.
